



# RECORDS.

#### THURSDAY, MAY 1, 1890.

The General Convention was called to order at 10:16 A.M., by Bro. Herbert L. Bridgman  $(\Gamma, '66)$ , of the Executive Council, who appointed as temporary President, Bro. S. P. Remington  $(\Sigma, '90)$ , and as temporary Recorder, Bro. R. W. Taft  $(\Sigma, '91)$ . Bro. Remington, on behalf of the Sigma, welcomed the delegates to Providence, and appointed the following committees:

#### FRIDAY, MAY 2, 1890.

#### MORNING SESSION.

The Convention having been called to order by the President at 10.30 A. M., the minutes of the previous sessions were read and approved.

Bro. H. C. Whiting  $(\Theta, '67)$  asked that, for the rest of the Convention, Bro. G. E. Reed  $(\Xi, '69)$  be recognized as the Alumni delegate.

The report of the Committee on Chapter Relations was then called up and after striking out the third section, it was unanimously approved, and the Committee discharged.

Bro. J. G. Deane  $(\Gamma, '90)$ , on behalf of the Committee on New Business, reported as follows:

General Resolution No. 3.—Resolved, That the petition from the University of Minnesota for a charter of Psi Upsilon be granted.

Bro. A. P. Jacobs  $(\Phi, '73)$  moved that the report be adopted. Bro. S. P. Remington  $(\Sigma, '90)$  seconded the motion.

Bro. A. P. Jacobs  $(\Phi$ . 73) moved that the discussion be postponed till the afternoon session. Lost.

After debate by Bros. A. P. Jacobs and T. H. Robertson  $(\Theta, {}^{9}1)$  in favor of the petition, and by Bro. F. S. Bangs against it, the resolution was adopted by the following vote:

#### AFTERNOON SESSION.

The President called the Convention to order at 2.30 P. M.

Bro. D. B. Kenedy, of the Chi, presented his credentials.

Bro. E. S. Tasker  $(\Xi, '90)$  on behalf of the Committee on Unfinished Business reported the following:

General Resolution No. 5.—Resolved: First.—That the Convention expresses its satisfaction with the general plan of the new Song Book, as indicated by the report of Prof. Harrington, Chairman of the Committee. Second.—That upon the completion of the manuscript of the Song Book and the preliminary editorial work, the Executive Council be, and hereby is, authorized to cause the manuscript as presented by the Song Book Committee to be published in such manner and on such terms as it may deem best.

The resolution was adopted by the following vote:

The Committee on Unfinished Business has examined into the matters in connection with the petition for a Chapter at the University of California, presented to the Convention of 1889, and has read the following papers:

First.—The petition.

Second. — The pledge of the Psi Upsilon Association of the Pacific Coast,

as printed in the Convention Record of 1889.

Third.—Letters of J. H. Brewer, dated June 25, and August 8, 1889; M. B. Kellogg, September 28, 1889; A. G. Lang, October 11 and 17, 1889—all to F. S. Bangs; and letter of F. S. Bangs to J. H. Brewer, dated July 2, 1889.

The Committee finds that at the time of the presentation of the petition and pledge mentioned, four of the eleven petitioners were not students in the University of California, and only five were candidates for degrees; that under the circumstances stated in the said letters, most of the petitioners were compelled by their associates to withdraw.

The Committee, therefore, recommend the adoption of the following resolution:—

Special Resolution No. 1.—Resolved: First.—That in the opinion of the Convention the Psi Upsilon Association of the Pacific Coast did not exercise proper care in regard to the petition for the establishment of a Chapter at the University of California, presented to the Convention of 1889. Second.—That the Convention expresses its displeasure that the petition mentioned should have been presented to the Fraternity under the circumstances then existing.

The four foregoing special resolutions were each unanimously adopted and the Committees on New and Unfinished Business discharged.

Bro. Geo. M. Hurd (B, '90), on behalf of the Committee on the Annual Communication, presented the following:

## APPENDIX A.

# THE ANNUAL COMMUNICATION OF THE EXECUTIVE COUNCIL TO THE CONVENTION OF 1890.

1. Membership.—The annual reports show an active membership of 422 on February 15th, 1890, a decrease of 15 below the membership of the previous year.

The Psi reports no initiations since 1888,

- 2. In Memoriam.—Hooper C. Van Vorst  $(\Theta, {}^{,}39)$ , died in New York, October 26th, 1889. An associate of the founders of the Fraternity, Judge Van Vorst retained always a lively interest in its welfare and prosperity, and his influence and efforts were ever at its service. At a memorial meeting at the Psi Upsilon Club House in New York, November 12th, 1889, an appropriate minute, expressing the sense of loss sustained by the Fraternity in Judge Van Vorst's death, was adopted, and a copy will be transmitted to the Convention. The Council adds its tribute to those which have already been recorded, and suggests that the Convention take suitable action.
- 3. APPLICATIONS FOR CHARTERS.—The petitions for chapters at the Universities of California and Minnesota, have been denied by the following votes:—

  \*University of California.—\*

For—Beta, Psi, Upsilon, Phi. Total, 4.

Against—Theta, Delta, Sigma, Gamma, Zeta, Lambda, Kappa, Xi, Iota, Pi, Chi, Beta Beta, Eta. Total, 13.

University of Minnesota.—

For-Theta, Beta Sigma, Psi, Xi, Iota, Phi, Pi. Total, 8.

Against—Delta, Gamma, Zeta, Lambda, Kappa, Upsilon, Chi, Beta Beta, Eta.
Total, 9.

The Gamma and Iota are recorded against the California petition, and the Delta and Zeta against both petitions, a majority, but not the necessary two-thirds, vote having been cast in the affirmative in each case.

An application for a charter by nine undergraduates of Dickinson College, Carlisle, Pennsylvania, has been received by the Council and is herewith presented to the Convention, accompanied with a letter of recommendation from President Geo. E. Reed ( $\Xi$ , '68), and Prof. Henry C. Whiting ( $\Theta$ , '67).

4. Finances.—The treasury of the Fraternity has been in excellent condition during the year. The treasurer's statement is hereto annexed. The balance on hand is \$1475.32, consisting of cash and deposits in the Broadway Savings Institution and the 4th National Bank, New York City. Of this sum \$386.83 is to the credit of the Convention Fund, and the remainder, \$1088.49, is applicable to the general uses of the Fraternity. It seems desirable that money should be gradually provided for the publication of the new song book, so that there may be enough on hand to pay for the work as it progresses, without the nec-

essity, as in the case of the recent catalogue, of borrowing on individual credit and imposing a burdensome assessment when the book is finally issued. For this and other general purposes a tax of \$1 per active member in 1891 is recommended.

Members of other fraternities have from time to time called the attention of the members of the Council to the fact that a judgment for \$269.30 recovered against the proprietor of The Diamond for printing that paper in 1885 and 1886 has been outstanding unpaid for several years. While it is quite true that The Diamond was an individual enterprise, for which the Fraternity was not responsible, and that its owner regards its debts as his personal affair, our Fraternity name was so connected with the paper that we have plainly incurred public discredit through its financial shortcomings. The matter has been considered by former Conventions, and the Council was once authorized to settle the claim, but the authority was withdrawn by the Convention of 1889, on Mr. Allison's personal statement of his own wishes. The failure to dispose of the judgment still continues, however, and has been urged upon us so frequently that the members of the Council feel impelled to say that, in their deliberate opinion, private considerations should now be outweighed by regard for the reputation of the Fraternity. The recommendation is, therefore, made that the Council shall be authorized to buy the judgment, so that it shall not, while unpaid, be held in an unfriendly interest.

5. The 10th Catalogue.—One hundred and five catalogues have been disposed of during the year, realizing, chiefly through the payment of assessments, \$515.91.

The Xi paid its assessment prior to the Convention of 1889, but too late for mention in the last Annual Communication. The Delta and Zeta have recently made their final payments with interest. The Iota, Psi and Eta are still in arrears and report that they have been unable to pay because of serious difficulties arising from various local causes. The matter may well be considered by the Convention with a view to some definite arrangement under which the debt may be paid in regular annual installments.

Enough copies of the catalogue remain unsold to supply any reasonable demand.
