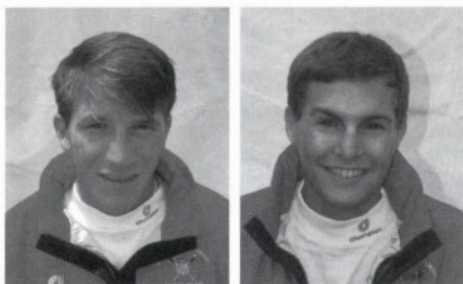
Olympic patriots

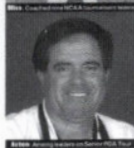

Remembering Lutz

The autumn/winter issue of The DIAMOND just arrived and I congratulate the staff for a professional product.

I noted with interest the innovative athletic article, and my eye caught the picture of Larry Lutz who was a contemporary of mine and played an important role in my career.

At the end of my freshman year, Brother Lutz and other upper-classmen encouraged me to participate in a non-academic campus activity. As a consequence, I turned out for crew in my sophomore year—simply as a chore. To make a long story short, I somehow got to the varsity and rowed in the NRA Regatta at Poughkeepsie (NY) in my junior year. That trip provided the otherwise unattainable opportunity for a poor west coast lad to be interviewed at eastern medical schools, the subsequent result of which was to be accepted to the Harvard Medical School. That fortuitous development became the springboard to a most interesting professional career, which can be said to have emerged from my Psi U experience.

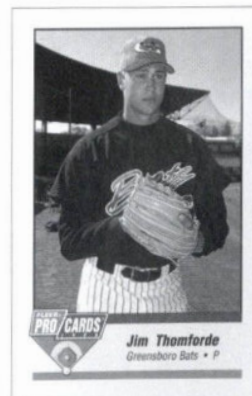
Of secondary importance is the fact that the

following year (1939) the same crew (on which I rowed bow) won the regatta and set a world record (which still stands because the four mile race was abandoned after WWII). That crew was inducted into the National Rowing Hall of Fame in 1979 and into the UC Athletic Hall of Fame in 1994. I hope this information may be of interest to our brothers in the bonds.

At the 1928 St. Moritz Winter Olympic Games, three Nus (University of Toronto) competed on the gold medal-winning Canadian hockey team: **John Porter '25, Norbert Mueller '29, and Frank Sullivan '23.**

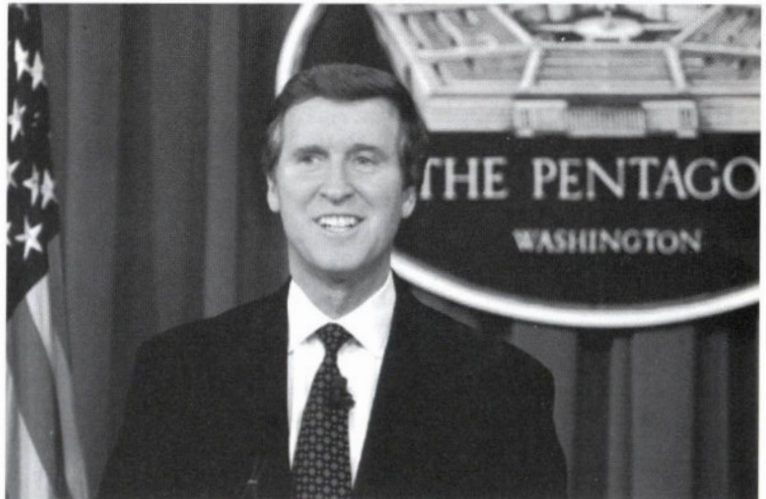

Democratic cabinet post since Defense Secretary Robert McNamara in the 1960s, he is the center of President Clinton's efforts to establish a bipartisan defense and foreign policy.

A moderate, independent thinker, and occasional outsider, Brother Cohen knows the Pentagon. Since 1979, he served on the Senate Armed Services and Governmental Affairs Committees. He was also a member of the Senate Select Committee on Intelligence from 1983-91 and 1995-97, and served as vice chairman from 1987-91.

The three-term Senator from Maine surprised Washington when he decided not to run for re-election last year. A pillar of the Senate, Brother Cohen chose to retire for several reasons: his increasing frustration with the cacophony in Congress; his desire to spend time with his new wife, Janet; his ambition to write a thriller; and his plans to affiliate with a law firm.

Plans for a varied retirement were put on hold when he accepted President Clinton's

by uniting behind a bipartisan security policy at home, Brother Cohen said his appointment respects the desires of the American people for an approach to public policy that is "free of political rancor."

Focusing on his goals as the president's second-term secretary of defense, Cohen stressed that America's global interests require both wise policies and the military strength to back up those policies. Acknowledging that America has the finest military the world has ever seen, he said the country must continue to attract and retain the highest quality men and women to serve in the Armed Forces. That means "we must do right by them when it comes to pay, housing, health care and other benefits for them and their families."

Presenting the Defense Department budget to Congress and getting the right balance of resources is an immediate concern for Brother Cohen. He also plans to work with the Senate on the ratification of the Chemical Weapons Convention; he

COHEN JOINS PENTAGON

WHEN WILLIAM S. COHEN, KAPPA '62 (*Bowdoin College*) was sworn in as America's 20th secretary of defense, the former G.O.P. Senator from Maine added to an already remarkable résumé which includes: lawyer, poet, novelist, mayor of Bangor, and well-respected congressman. The first Republican named to a senior

nomination as secretary of defense, arguably one of Washington's most demanding jobs. "I am fully conscious of the heavy responsibilities that come with this assignment," Cohen said at his swearing-in ceremony at the White House. Clinton, who praised Cohen's years as a Senator and Congressman, congratulated him on the swift confirmation of his nomination. "It says a great deal about this extraordinary man that his Senate colleagues paid him the tribute of a unanimous vote of approval," Clinton said.

Sharing Clinton's conviction that America can best defend her national security interests abroad

anticipates completing a quadrennial defense review that will provide a framework for

allocating defense resources into the next century; and he wants to ensure U.S. forces have the "technological edge to win quickly and decisively" through modernizing the U.S. arsenal.

Other issues on the agenda: dealing with the military's recent incidents involving hazing and sexual harassment; protecting troops from terrorism, chemical and biological weapons; getting troops out of Bosnia by June of 1998; and working with Russia on

the Strategic Arms Reduction Treaty II and its concern over the expansion of NATO.

An influential voice on defense and international security issues, Brother Cohen played a leading role in crafting the Goldwater-Nichols Defense Reorganization Act of 1986. He was the Senate sponsor of the GI Bill of 1984 and the subsequent enhancements to this landmark legislation. His efforts led to the creation of the Rapid Deployment Force, which later developed into the Central Command, and the maritime prepositioning program, both of which were key to the success of the Gulf War. He also co-authored the Intelligence Oversight Reform Act of 1991, as well as legislation designed to overhaul U.S. counterintelligence efforts and defend against foreign, political, and industrial espionage.

From the Competition in Contracting Act of 1984, which he authored, to the enactment of the Federal Acquisition Reform Act of 1996, which he played a key role

in drafting, Brother Cohen has been in the forefront of reforming the federal government's

procurement process. Committed to bringing accountability and the private sector's best practices to government agencies, he also authored the Information Technology Management Reform

1997, and in 1996, he chaired the council's Middle East Study Group. He has also chaired and served on numerous study groups and committees at the Center for Strategic and International Studies, School for Advanced International Studies, and

Act of 1986 to improve the way federal agencies manage information technology investments and streamline the acquisition process.

Brother Cohen served on the board of directors of the Council on Foreign Relations from 1989 to

Brookings Institute, on issues such as Department of Defense reorganization, NATO enlargement, and chemical weapons arms control. Since 1985, Brother Cohen has led the American delegation of senior Executive Branch officials and Members of

Congress to the Munich Conference on Security Policy, which brings together senior officials from NATO and Partnership for Peace countries. He also led American delegations to the American-Arab Dialogue in Cairo and the Pacific Dialogue in Kuala Lumpur. Both are regional conferences on security and economic issues.

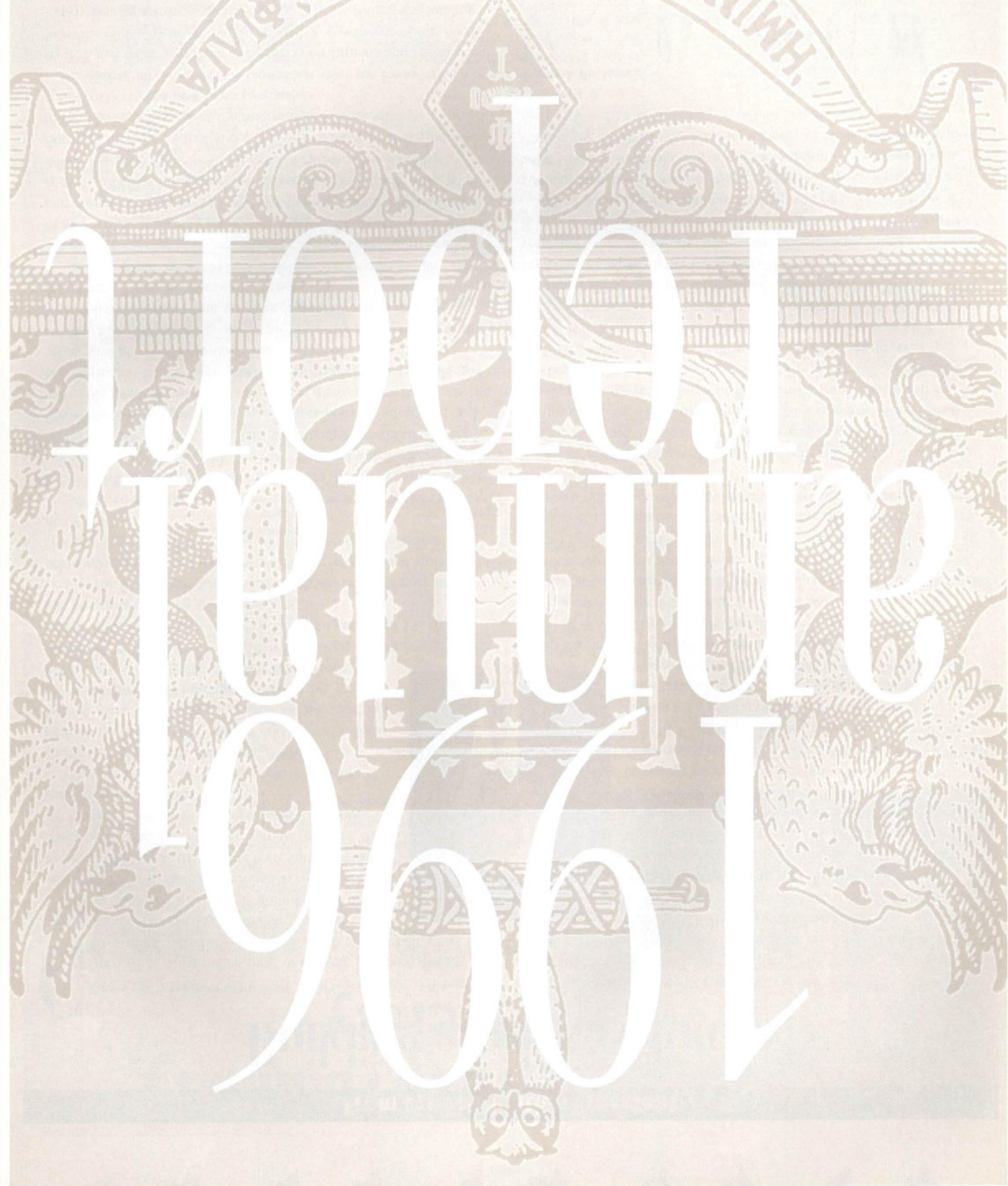
In 1974, Brother Cohen was selected by TIME magazine as one of America's 200 future leaders. The U.S. Junior Chamber of Commerce named him one of the Ten Outstanding Young Men in America in 1975. In 1975, the Boston University Law School honored him with its prestigious "Young Lawyer's Chair," and in 1976, the Boston University Alumni Association presented him with its Award for Distinguished Public Service. In 1980, he received the "Vanguard" award from the Non-Commissioned Officers Association for his work on behalf of military personnel in 1983, the same association also honored him with the L. Mendel Rivers Award. In 1996, he received the U.S. Special Operations Command Medal.

While an undergraduate at Bowdoin, Brother Cohen received his B.A. in Latin. He received his LL.B. cum laude from Boston University Law School in 1965. While practicing law, he was elected to the City Council of Bangor, 1969-72, and was Mayor in 1971 and 1972. In 1974, while serving on the House Judiciary Committee, Cohen voted for President Nixon's impeachment. After serving three terms in the House, he defeated Senator William Hathaway, a Democrat, for the Senate in 1978.

He has authored or co-authored eight books, including two books of poetry, three novels, and three works of nonfiction. ♦

Building a brighter future

COLLEGE FRATERNITY LIFE TODAY is vastly different from what it was when most of us were in school. Society faces many daunting challenges which are not being met or even helped by modern academic institutions. Our culture is becoming increasingly complex and diverse while traditional classroom education too often fails to provide the tools that young men and women really need. Thanks to many generous brothers, the Psi Upsilon Foundation has been able to provide some of what has been missing.

The Foundation saw many positive developments in 1996. The Annual Fund continued to provide needed resources for our educational mission. In fact, more of you gave more money last year than the year before. The Founders' Society, the Foundation's elite giving club saw an increase in members, from 95 in 1995 to 132 in 1996 and the Anniversary Club, which recognizes donors who give \$1.00 for each year Psi Upsilon has been around, grew to 64 members.

For the first time in several years the Annual Fund goal was achieved and exceeded. And it was done by keeping our fund raising cost per dollar raised the lowest of any fraternity foundation anywhere.

And of course, the money went to support a number of vital educational programs. The first Treasurers' Academy was held last summer in conjunction with the 1996 Leadership Institute. The third Archons' Academy took place and was another outstanding success. Undergraduate presidents came to Indianapolis for an intense and enjoyable weekend and took home with them an enormous amount of information which helped them make their chapters and themselves stronger. The Foundation also gave out 17 scholarships totaling \$24,000, which is one award for every two chapters in the Fraternity, something that no other fraternity comes close to matching.

In July, while the world was watching the Olympics, the Foundation dedicated its new headquarters building, a magnificent facility which provides educational facilities for the many programs and meetings conducted throughout the year, archival and library space, staff office space, and living quarters for the field staff; all of which has been made possible without extravagant spending. Starting this year each of you will have a chance to etch your mark in the Heritage Square at the International Office with your special contribution to our new brick program.

In spite of all the success achieved last year, the Foundation's work is just beginning. Your generous contributions and the income from the endowment are barely enough to meet some of our needs today. But tomorrow is another story. While scholarships totaling \$24,000 are something we can all look to with pride, most of you know that it costs that much for one of our undergraduate brothers

to attend some of our schools for just one year. Our educational programs are only scratching the surface. The Archons' Academy needs to be expanded and held more often. Academies for alumni

leaders and other undergraduate officers are desperately needed. Seminars and retreats which contribute to the personal growth and development of our members can only be held occasionally in spite of their overwhelming value. This needs to change. A group of very dedicated volunteers has been conducting a unique series of weekend retreats for some of our chapters, but resources are limited and not every chapter can be reached with this program.


The Foundation has embarked on an ambitious capital fund raising program so that it can dramatically expand its educational programs, academies, seminars, educational retreats and scholarships to deserving brothers everywhere. And it needs your help.

To permanently and exclusively devote principal and income from property that the corporation may hold to the stated educational and charitable purposes.

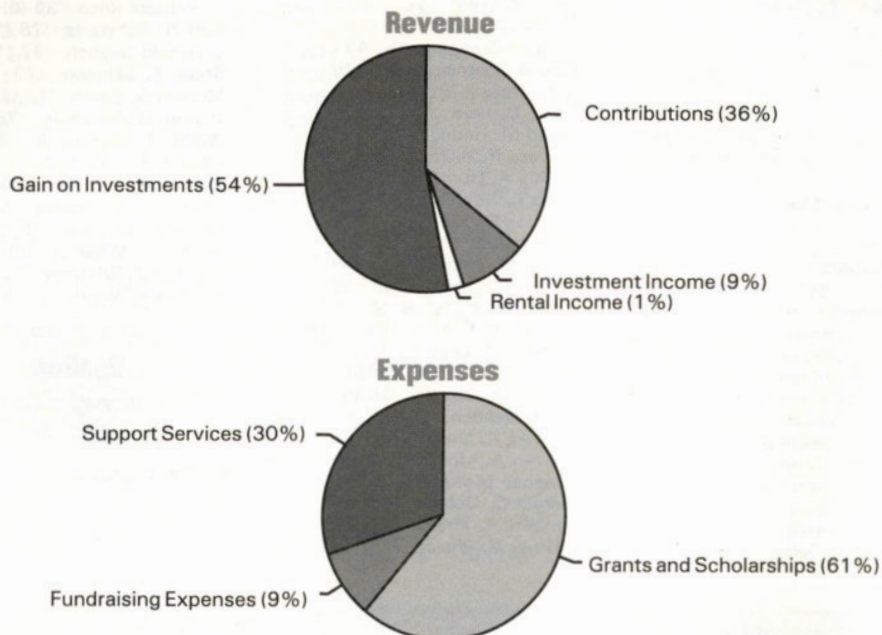
**What is the Foundation's

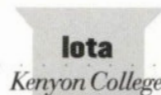

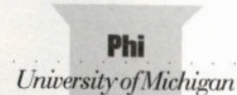

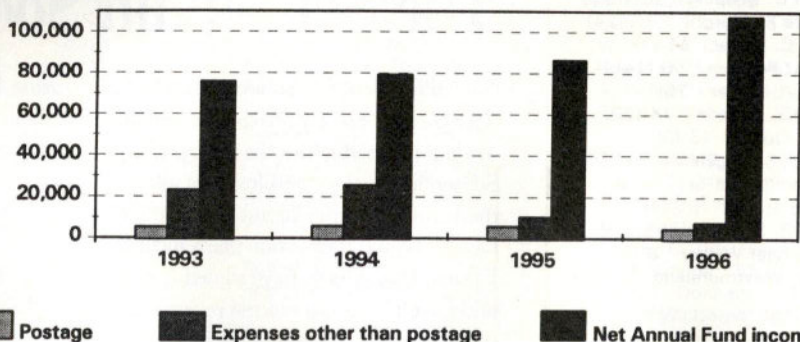

The following list includes brothers whose deaths were reported between November 16, 1996, and March 8, 1997.

William B. Galbraith, Delta '41 passed away on September 5, 1996.

Brother Galbraith was one of the original instructors at the Palm Beach Junior College where he taught for 29 years. He retired in 1985 as a senior instructor. While in West Palm Beach, he helped form the Adult Education Program, helped start the Science Museum, and was the original curator of the planetarium.

He is survived by his wife, Dorothy; a son; a daughter; three granddaughters; and his cousin, *Rally Dennis, Lambda '40 (Columbia University)*.

Wallace R. Chandler Jr., Sigma '16 passed away on July 19, 1996.

After receiving his law degree from Harvard in 1921, Brother Chandler was an assistant district attorney in Providence, R.I. From 1930 to 1971 he practiced with Riker, Danzig, Scherer, Hyland & Perretti in Newark, N.J. He was an ensign in the Navy during World War I.

He is survived by a daughter.

Robert E. Newcomb, Gamma '37 died on October 19, 1996, after a long struggle with cancer.

Brother Newcomb was a graduate of the University of Pennsylvania Law School and was a corporate attorney for the Campbell Soup Co. for 35 years. While living in Glassboro, N.J., he was a member of the Board of Education and a member of the Glassboro Planning Board. He also spent many years as a trustee of the Glassboro Public Library. 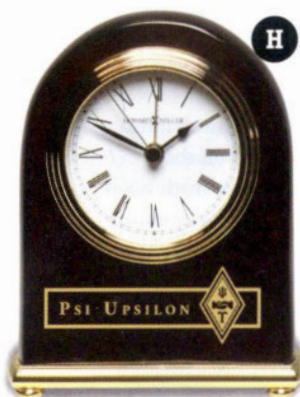

1987 10 Years Ago...

The Fraternity's chapter roll included 32 active chapters... One of Psi U's most prolific authors, **Horatio Alger, Alpha 1852 (Harvard University)** had his 104th book published—109 years after its scheduled publication date. *Mabel Parker; or, The Hidden Treasure* was never in print because the original publisher went bankrupt... The Executive Council granted Delta Kappa Phi, a local fraternity at Pennsylvania State University, provisional chapter status. The Kappa Phi chapter was formally installed in 1989... The undergraduate membership totalled 1,508.

California—Berkeley) and his wife, celebrated its fiftieth anniversary at the White House. More than 100 guests were in attendance for the white-tie party given in the State Dining Room by President and Mrs. Nixon.



1972: DeWitt Wallace, Epsilon '17 (*University of California—Berkeley*) was honored at the White House on the occasion of the 50th anniversary of *Readers Digest*.

The Executive Council unanimously voted to hold the 105th Psi Upsilon Convention in Seattle, under the auspices of the Theta Theta (*University of Washington*). Because of World War II, no chapter had been able to host the Convention since 1942... Undergraduate membership totaled 1,134, up from 437 the previous year, and 253 the year before that. The average undergraduate membership in pre-war years was 875.

1922 75 Years Ago...

The Fraternity's chapter roll included 26 active chapters... The Psi Upsilon Club of New York moved into its new home on East 39th Street... The Fraternity congratulated former President **William Howard Taft, Beta '78 (Yale University)** on his appointment as Chief Justice of the Supreme Court and his "many examples of service and loyalty to Psi Upsilon"... Undergraduate membership totaled 913.



1972 25 Years Ago...

The Fraternity's chapter roll included 27 active chapters... *Readers Digest*, co-founded by **DeWitt Wallace, Epsilon '14 (University of**

1947 50 Years Ago...

The Fraternity's chapter roll included 28 active chapters...

1922: The sophomore delegation of the Beta (*Yale University*) performed "In the Grip of the North." The chapter customarily held a play in conjunction with its fall and spring initiations. Frequently more than one hundred brothers attended the annual event which would be followed by a banquet.





1922: Former President William Howard Taft, Beta '78 (*Yale University*) was appointed Chief Justice of the Supreme Court.

fated Alpha (*Harvard University*), admitted in 1851, occurred.

1847 150 Years Ago...

With 10 chapters, Psi Upsilon was the largest fraternity in existence... **Francis Miles Finch, Beta 1849** (*Yale University*), author of the first Psi U songs, was initiated... The Xi chapter moved into rooms in Brewer's Store on the corner of Main and Court Streets, Middletown, Conn... The recently published general catalogue included 802 names.



1847: The third edition of the Psi Upsilon Catalogue was published. Still published today, the catalogue is now called the alumni directory.

1897 100 Years Ago...

The Fraternity's chapter roll included 21 active chapters... President Wayland of Brown University began his relentless war on fraternities and said that no meeting could be held "unless at such time and place as the president may direct"... The Lambda (*Columbia University*), for the first time, had its own house with rooms for its members... Undergraduate membership totaled 507.

1872 125 Years Ago...

The Fraternity was 15 chapters strong... First annual dinner of alumni in New York City was held... The second and final dissolution of the ill-

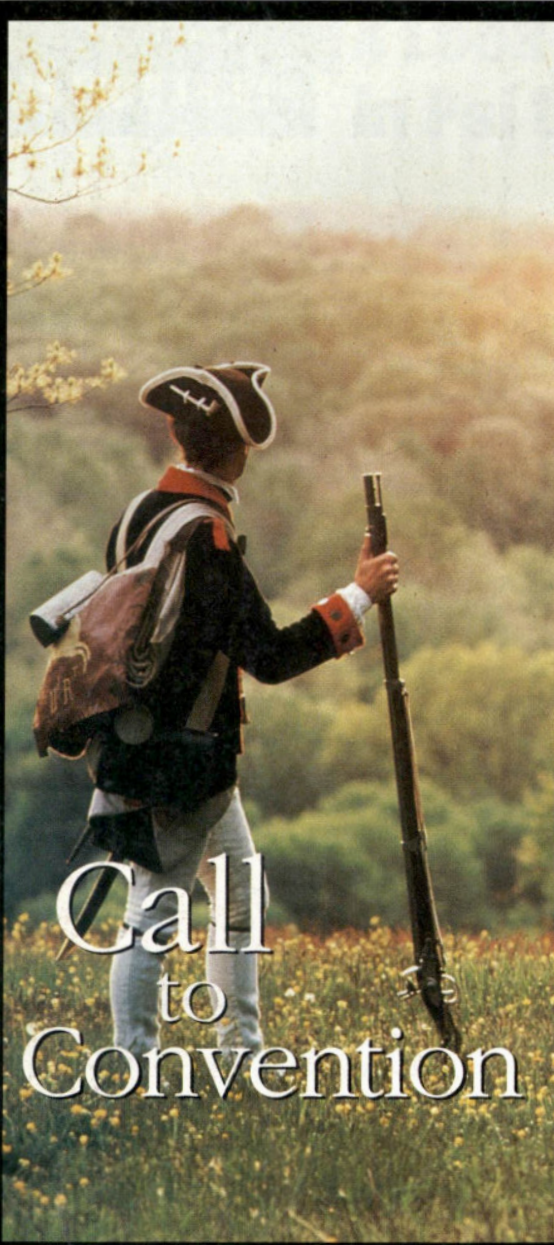
