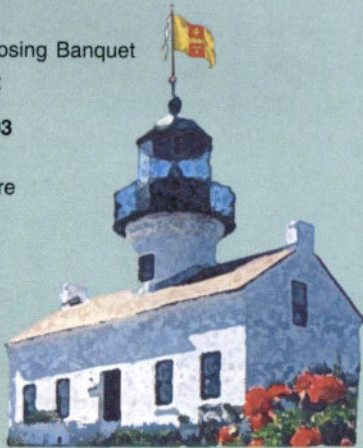

# Celebrating Sam

**T**he step up into the Park Ridge home makes Sam Biardo Sr. look even bigger as he comes to the door. A burly bear of a man, he looks solid, the kind of man young kids flock around on a soccer field in order to feel safe. But as he turns away from you to enter the room, you catch sight of his eyes and you know, in some innate way, that that is what grief looks like – that dark flooding color that flits across in a ghostly pass, a momentary hint of the merciless prowler that, anywhere, any moment, could easily fell even a big man like him.

He is unfailingly polite but uneasy, and we both know why. The tape recorder and yellow pad set out on the table look harmless, but they threaten to once again eviscerate him as he talks about the loss of his son. But he will tell me later, though he is not a religious man, “The church has the right idea. ... They celebrate life, and they celebrate death. You’ve got to do it.”

And so this is what Mary and Sam Biardo are doing – learning to celebrate the life of their son, doing his young life justice by memorializing all that was good.

Upon closing the door to high school, incoming students to the University of Illinois knock on the campus gateway marked “firsts”: the first time away from home, the first time living with a stranger, perhaps the first time they fall in love.

Similarly, these students’ parents buck up as they peek through a personal portal of nostalgia and hope, recalling their own forays into a brave new world and the opportunities they then saw shimmer so brightly before them.

In the fall of 2000, the young men who would become brothers at the Psi Upsilon fraternity on cam-

pus and the parents of Sam Biardo Jr. were unaware that they would come to share another first: a staggering loss through death and an unforeseen coming together to mourn collectively with the dignity and respect young Sam deserved.



Sam Biardo Jr. had his heart set on attending Illinois, and, as was his wont, corralled more than a few of his friends to attend along with him. “I remember him saying one night to me in the [fraternity] dorm, ‘I just really wanted to go [to Illinois], it’s a good time, good academics,’” said Matt DalSanto, one of Sam’s pledge brothers at the fraternity. “I also think he liked the fact it’s a big school.”

Sam settled in at the Florida Avenue Residence Halls, enrolled in a math curriculum and started gathering even more friends than he had had in his years at Maine South High School. Zennis Lee, a high school friend and fraternity brother, recalls Sam, with his “disarming smile,” sitting out on the house stoop one day, seeing how many passers-by he could strike up a conversation with. An easy talker who could make people laugh, Sam reached out to personality types across the board and “could find something good about you,” said fraternity brother Frank Bieszczat. So when Sam passed away the next semester of a previously undiagnosed heart condition, “he died as he lived,” his mother said as she recalled the hospital room full of family and friends, “— the center of attention.”

Sam had gone home to Park Ridge in late February 2001 to do his laundry. Not feeling well, he was put on antibiotics because X-rays showed his lungs were filled with fluid. Further testing revealed an enlarged heart and his condition – non-specific idio-

pathic cardiomyopathy. The seriousness of his condition became rapidly apparent (“The word ‘transplant’ came into our vocabulary on Day Two,” Mary recalled), and he stayed at his parents’ home the rest of that spring semester to recuperate. Sam received a pacemaker defibrillator; the electrical problem with his heart made him ineligible for a transplant. But he continued to visit the Urbana campus, even drawing up with his fraternity brothers a wicked Top 10 list of activities to avoid in order not to give him a heart attack (i.e., no doorbells or alarm clocks, no standing in front of the microwave, etc.).

On Friday, April 20, Sam suffered massive cardiac arrest at age 19 at his home and was disconnected from life support two days later. Mom’s Day weekend on the U of I campus was just coming to a close.



Mary Biardo, 44, is a small woman whom grief has shrunk from a size 12 to a size 2. Her petiteness forces her to tilt her chin up to look you full in the face, making her countenance appear even more friendly and open. She is quick and birdlike, energetic and garrulous. She says of people who fear such a tragedy befalling them, “We are their worst nightmare.”

Both she and the fraternity brothers recall the link formed between them as something they just fell into. Perhaps it started from the fraternity side when, even before Sam was taken off life support, the brothers stood around the piano and decided to dedicate a phi-

lanthropy in his memory. Perhaps it started from the Biardo side when Mary asked permission from the fraternity to wear Sam’s pledge pin at his wake.

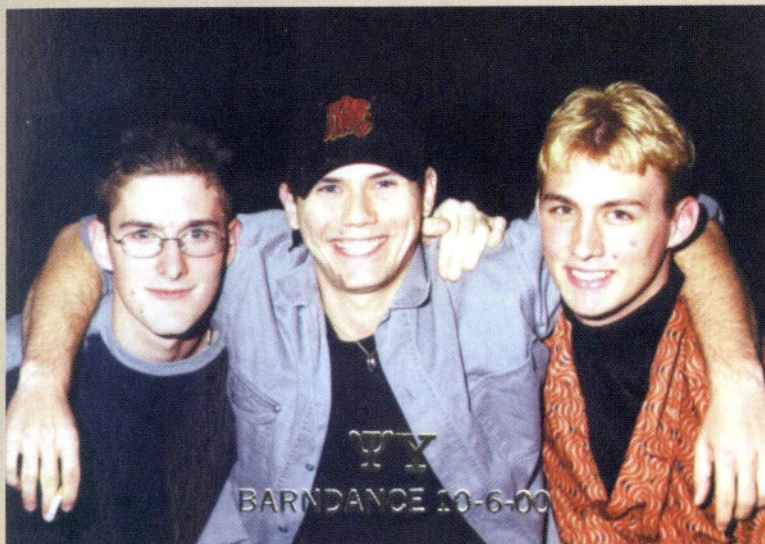
You wonder what brought together fraternity brothers who could cry and hold each other after Sam was gone, what united them with parents who cared about their son’s friends’ grief. You wonder what was working decades ago that made Mary save nearly every single article from Sam’s childhood, now carefully preserved in a curio cabinet in their living room. There are trophies and a baby bracelet, Star Wars figures and items representing private family jokes. “I wanted to have him in the house,” she says.

And later, “I never expect to get new memories.”



“I think the first time I ever met him ... I was just thinking to myself, ‘Who is this guy, man, he seems to know everyone,’” said fraternity brother Alex Barlan.

"He was basically one of the nicest people you'll ever know."

"I think sometimes when people pass away, you'd like to just remember the good things about them and try to exaggerate some of their better qualities," DalSanto said, "but ... that's why [Sam] was so mind-boggling. I remember thinking even while he was alive that I've never met anyone this happy and energetic 24/7."

Bieszczat says of his pledge brother Sam, "I think the thing I remember most is that the littlest thing would get him really excited. I think that's why he was so happy – because he could get excited about anything and everything. There was one time when somebody put mayonnaise on their hamburger, and he went off for like 20 minutes on why you shouldn't put mayonnaise on your hamburgers."

And so one would think the story of Sam and his fraternity brothers would have quietly and naturally wound down that summer of 2001. In April 2002, however, fraternity brothers manned a table on the Quad, running an organ and tissue donor awareness drive and raising funds for the Regional Organ Bank of Illinois (now called Gift of Hope). A fallen brother ceremony was held, with the Biardos spreading some of Sam's ashes on the fraternity lawn. Sam's parents have been initiated as honorary members of the fraternity, and in May 2002, the first Psi Upsilon

Foundation scholarship in Sam's name (the Sam Biardo Memorial Scholarship) was awarded. In October 2002 Sam Biardo Sr., 48, and a score of fraternity brothers celebrated in New Orleans what would have been Sam's 21st birthday, fulfilling a past promise made to his son. And previously, Mary and Sam had offered counseling sessions in their home for Sam's friends the summer after Sam died. "I didn't want them to be messed up further on in their lives," Mary said. "From everything that I've read, how you handle the first [significant loss] is how you're going to handle the rest of them."

The scholarship in Sam's name "is a nice way to remember Sam, to keep his name alive," Mary said. "Sam always wanted us to be

generous not just with him but with his friends, so this was a way [to do that]."

“That’s the reason we picked the University,” Sam Sr. said. “This was the money going right to someone, every dollar.”

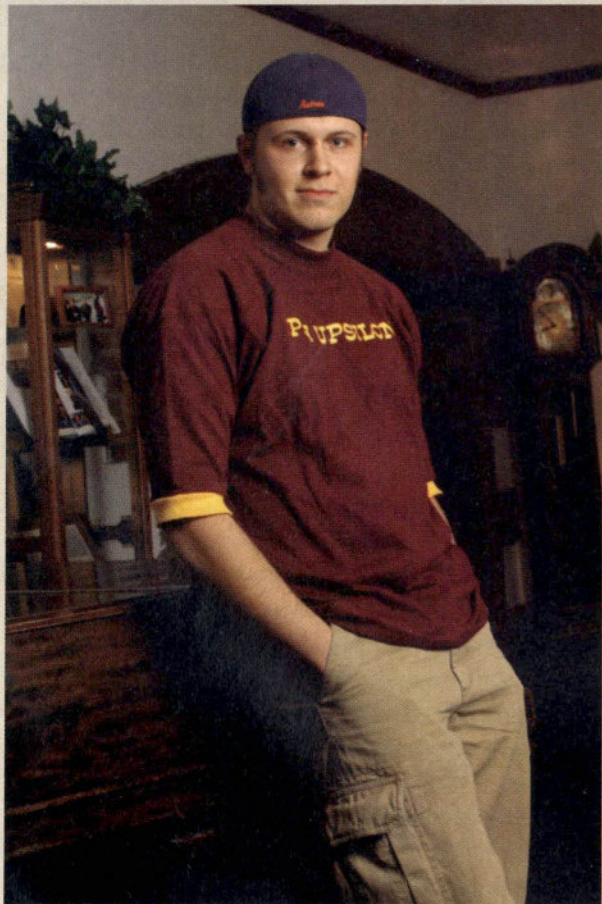
The efforts made on behalf of Sam “give us two things,” said Bieszczat. “It gives us something physically to remember Sam and to do something for him. At the same time, every time they come down here, [the Biardos] kind of get a part of Sam; they talk to us and sort of get a part of Sam they didn’t know. And every time we talk to them, we get a part of Sam that we didn’t know.”



When it comes time to leave the University, each of us makes sure to carefully pack up memories – the challenge of study, the warmth of good friends, the look and feel of life on campus. For the brothers of Psi Upsilon, one item in their memory boxes will be

young Sam Biardo – his passion and zest for life, his humor, the lasting shock of his untimely death.

And they will know that as their untested selves struggled with grief, the bonds of brotherhood began to deepen rather than disintegrate.

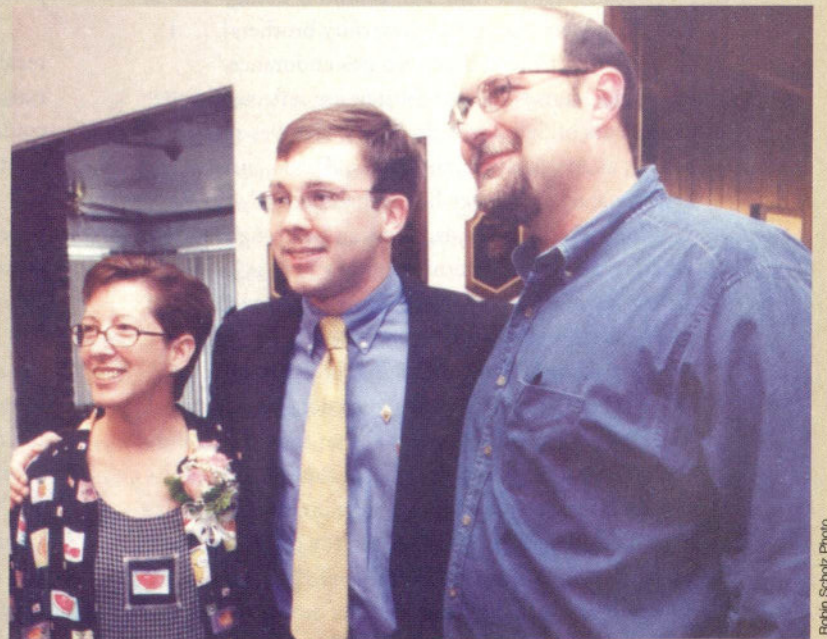

# 'An Extraordinary Family, Extraordinary Young Men'

John Powell, a UI counseling psychologist, sits in his office on a cold winter day, clad in a sweater and jeans, marveling at the Biardo-Psi Upsilon story. "It's phenomenal," he said of the coping relationship that has developed between the two sides following young Sam Biardo's death. "It doesn't happen often."

And he should know. Having spent nearly two decades as a counselor at Illinois, with an emphasis on grief work, Powell has been able to observe up close how student life has changed over the years. "The inter-generational bond is pretty fascinating," he said of the relationship between the fraternity and Mary and Sam Biardo Sr., because in general "this is a generation that has grown up with an absence of clear, adult figures in their lives, with few substantive, three-dimensional adult models. ... What kids need is to watch how an adult handles an intense and painful reality."

That pain involves coping with Sam's death at age 19 of a previously undiagnosed heart condition.

"I suspect that what Mr. Biardo is doing," Powell said, "is re-sensitizing [the fraternity brothers]. ... I think [he], for them, demonstrates endurance."

The counselor's observations are reflected in the statements of Sam's friends. "For me, it was really reassuring, and it always is, to see Mr. Biardo, just because I am amazed at the way he has handled it," said Psi Upsilon's Matthew Cajda, who can be brought to tears when recalling his fraternity brother. "He is just so strong about it ... just to see the way he handles it gives me strength."

Powell finds the instincts that both sides had to move in healing and growthful directions quite unusual.

"What typically happens is that fraternities and sororities pull together quickly [in times of tragedy], but then the outside demands take precedence. ... It's hard to find permission to do healthy things for themselves, but this group has given itself that permission. Our culture doesn't let us take time out, reflect, say, 'I need to deal with what happened.'"

"I think a lot of credit goes to [the Biardos] personally because they have been open with us," said fraternity brother Matt DalSanto. "We couldn't have had

the relationship we've had if it would have been any mom or dad. ... And to give our chapter some credit, I think our guys have been open about it and not try acting real tough, and you know, like, 'It doesn't bother me; I'm over it now.'"

Katherine Reed, a clinical social worker in California familiar with grief work, believes matching interests account for the bond between Sam's parents and his college friends.

"If you picture a series of concentric circles with the person as an individual in the center," she said, "typically university students who have joined a fraternity or sorority have moved the fraternity or sorority into the circle immediately beyond the self, displacing the family." Mary Biardo's interest in the importance of the fraternity in her son's life coincides with the importance the brothers place on it, Reed said.

Both Powell and Reed believe that grieving young people are struggling with issues for which they are little prepared to find answers. Powell says a death often pushes this age group into an existential crisis.

"When [Sam died] ... I was really, really angry," recalled fraternity brother Frank Bieszczat. "You try to rationalize it and think about why it happened, and I couldn't come up with anything, and it was just very frustrating. ... You think when you get older, your kids will play with his kids ... and now things like that will never happen, and you really do feel cheated. Like there's that whole part of your life that you're supposed to have, and you're never going to."

Powell theorizes that memorializing Sam through the scholarship and organ donor awareness campaign is a way for Sam's friends to grapple with answers to the big questions and gives them a way to redefine their brotherhood in another significant manner.

Fraternity pledge brother Ron Hobbs said, "Even though you die, you still serve a purpose once you die. I'm not saying this is Sam's purpose, but when Sam died, I saw people in this house come closer to each other and just show their true feelings to each other, and I think it made us a better house as a whole."

Powell likens working through grief to viewing an art gallery. "When a person dies, that person is the

[main] picture you see,” he said. “The goal of grief is to discover where to position this picture with all the other things in your life – what hallway does it go in? Where does Sam’s picture go in my life?”

And some of those close to Sam are starting to learn where to place that picture.

“The way Sam led his life – with what happened, he wouldn’t want us to grieve and stop our lives,” said fraternity brother Amul Ganger. “He’d want us to conduct our lives and go out and have a good time on his part to celebrate his passing rather than mourn his passing. And that’s just how outgoing he was.”

In their own attempts to work through their grief, the Biardos have actively tried to heal – through counseling, books, the compassion of friends, accepting change, being open with their feelings and realizing the futility of avoidance.

“For us to sit back and just vegetate,” Mary contemplated, “I don’t think that celebrates his life in any way.”

“We’re happy that we had 19 1/2 years,” she said. “We’re better people for it, so let’s show it.”

But to understand the enormous recovery the Biardos have striven for following their son’s passing, consider Mary’s chilling comparison of the events of 9/11 with the death of a child:

“If you want to understand a little bit more of what it feels like [to have a child die], think of yourself as one of those towers, and think of the jet just coming into your chest, smoldering, exploding, and then you crumble. There’s chaos, people saying, ‘Oh, everyone’s going to be all right.’ No, everyone’s not going to be all right.”

But somehow, the Biardos and the brothers of Psi Upsilon have worked together and managed to become just a little bit better.

“[The situation] is extremely rare,” Reed said, “and points to the coming together of an extraordinary family and extraordinary young men.”

# The Facts Tell Us We Carry a Large Responsibility

Last spring the North-American Interfraternity Conference (NIC) developed a list of talking points regarding Greek life on American college and university campuses today. That list, which appears below, was shared with members of the U.S. Congress and congressional staff members who are alumni of Greek organizations at an annual reception held in Washington, D.C.

These facts suggest a community of enormous influence unlike any other on our collegiate campuses. These facts also suggest that as a community we have an enormous responsibility. Because of our size, our

breadth, and the diversity of our constituent organizations, we have the potential to be a powerful force in higher education. The choice we continually have before us, however, is whether we will be a force for positive influence or negative influence.

We are the largest and most visible values-based organization on campus, but if the values we teach and, more importantly, the values we demonstrate run contrary to our own ideals or the educational missions of our institutions, we fail not only ourselves and our chapters, but

our Greek community and everyone for whom we could have been a positive force.

We are the most successful leadership development program for college students, but leadership is a shared responsibility. It is a responsibility that must be shared by every member of every one of our organizations. Perhaps the greatest responsibility we all have in this regard is to be true to the values and ideals we espouse—to walk the walk, not just talk the talk, and to hold each other and ourselves personally accountable for being leaders in this



regard. These are not monumental challenges. They are day-to-day challenges. They are mundane. Perhaps that is why it is so easy to let them go at times.

Our choices are quite simple: I will strive to live by the principles and ideals my brothers, my sisters and I have pledged to uphold or not. Our answers will determine whether we can continue to say we are a positive force, or merely that we could be a positive force.

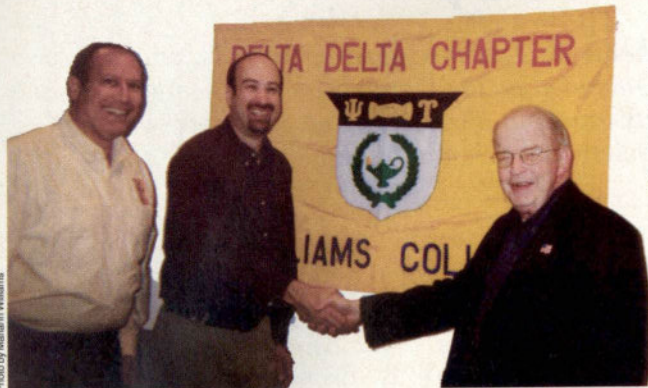

## Leadership Institute

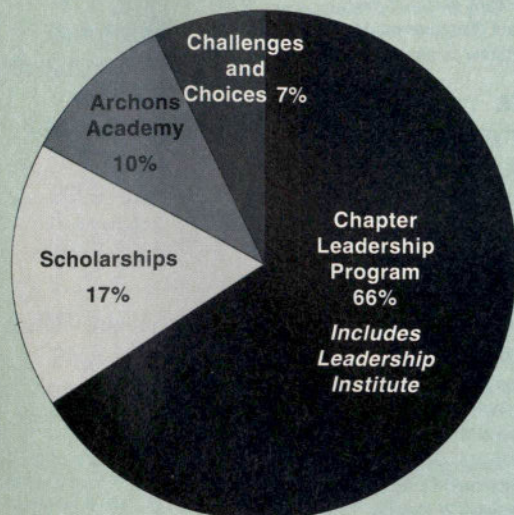

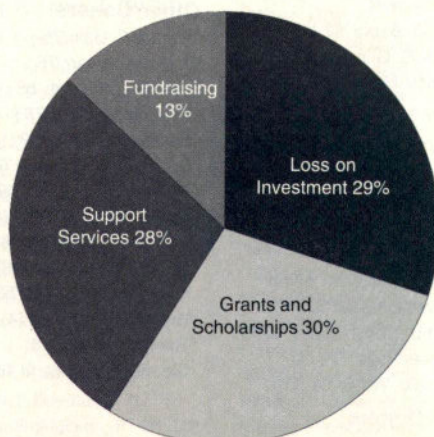

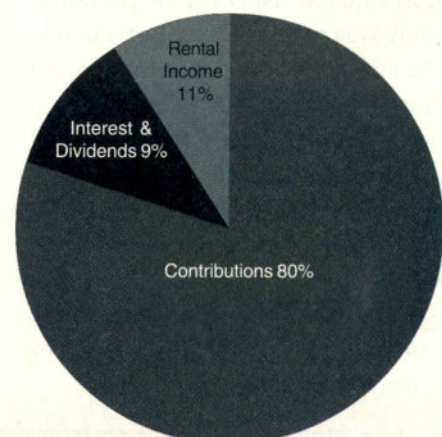

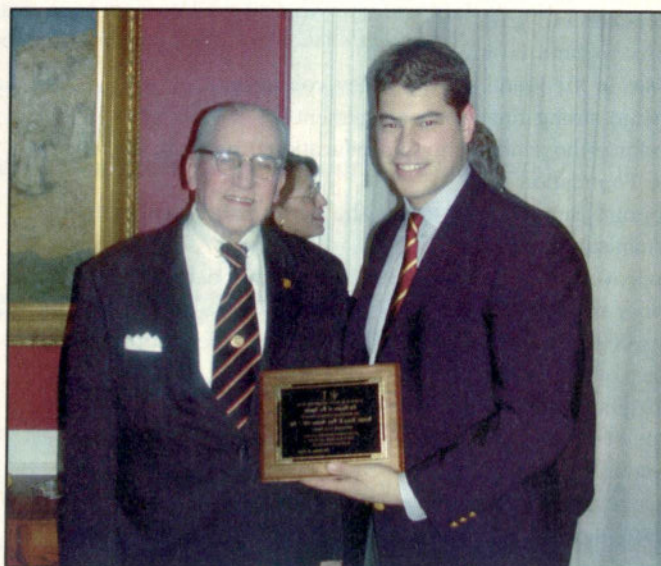

# Origin & Creation of the Psi U Badge

A committee led by founder, Charles Washington Harvey, consulted with Luke F. Newland, a noted jeweler in Albany who designed the cherished Psi Upsilon badge. The badge was first worn publicly in June 1834.

During Psi U's early years, badges were created at local jewelers and therefore these badges varied slightly.

Today, the Psi Upsilon badge is created by Psi U's official jeweler, Burr, Patterson & Auld. While the badges are uniform, each badge is carefully made by the hands of skilled artisans.

First, a hand-made die is filled with wax and a wax replica is created. This wax replica is then



submerged in composition and placed in an oven overnight. The wax melts out, leaving a form for the jeweler to pour in the metal. The badge is then cast and the hardened composition is removed from around the badge. Next, any sharp edges are removed, then the

joint and the pin catch are soldered onto the back of the badge. The black enamel is brushed on and allowed to set. The badge is then sandblasted and polished. The back of the badge is engraved and hand polished again. If the badge is not 10K gold, it goes through a plating process before it is inspected, packaged and shipped to a Psi U brother. ♦

**John “Jack” Kennedy Brynes, Pi '60** died on November 4, 2002 after a long illness. He was 65.

Brother Brynes completed ROTC Flight Training School where he was commissioned a second lieutenant in the U.S. Air Force. During his tour of duty and promotion to captain, he flew C-124 military air transports during the Vietnam War and the Cuban Missile Crisis. He then earned a master of science degree at Syracuse and taught social studies for 26 years at Lake George High School, his alma mater.

He was a member of the Syracuse University Alumni Association, American Council of Social Studies Association of American Geography and the Lake George High School Alumni Association. For 15 summers he worked with the New York state Conservation Department.

He enjoyed family activities, genealogy, hiking, flying and sailing on Lake George. He was a member of St. John's Hospital Foundation, and a long-standing member and treasurer of Abraham Lincoln Association. He was a past Board Member of Springfield College in Illinois. He was a board member of several other organizations.

He is survived by his wife, Florence.

**Herbert Stephen Casey, Jr., '49**, died on June 27, 1999 following recovery from a stroke. From 1942-1945 he served with the Army Air Corps. For 30 years he lived in New York and was CEO of Computer Sound Corporation. He was an avid skier. During his retirement in Falls Village, Conn. he was a member of the Northwestern Connecticut Transit District, a volunteer at Sharon Hospital, and a Justice of the Peace. He was named volunteer of the year in 1993. He was also a member of Alcoholics Anonymous for more than 41 years and was active in many AA groups in Connecticut, western Massachusetts, and New York City. He is survived by a brother, W. Verner Casey '48.

**William Hampton Corwin, Psi '33** died at the age of 91 on October 22,

He is survived by his wife, Marjory.

**Herbert H. Davis, Theta Theta '32**, died at the age of 91 on April 8, 2000. As a young boy he had polio but overcame it to play midget football in high school where he was student body president and won an award for sportsmanship and scholarship. He graduated from the University of Washington law school and was an attorney for the Washington State Tax Commission.

In 1942, he married Constance Bailey and was then drafted as a private in World War II. He rose to the rank of major in the Air Corps Judge Advocate General Department stationed in Colorado Springs. Following the war he joined the King County Prosecuting Attorney's Office as Chief Criminal Deputy in Seattle.

In 1949 he entered private practice with Maloy Sensney. He was in the Prosecuting Attorney's Office for Benton County for 20 years as Deputy and later as Prosecutor. After retirement he served as Court Commissioner for Benton

After 27 years of service in the Navy, Gulick retired in 1962 with the rank of Captain. He spent his first civilian year working for Aerojet General then entered the field of investments with Dean Witter and Co. in Santa Monica.

Brother Gulick's favorite pastimes included the company of his Academy classmates and friends, golf, fly fishing, flying and finally his computer.

He and his wife, Sally were married 61 years. In addition, he is survived by his two brothers including Brother George W. "Bill" Gulick, Iota '40.

**George N. Hilfinger, Pi '41**, died on December 17, 2002. He was 82 years old. Brother Hilfinger was a veteran of the U.S. Navy during World War II. He was captain of the crew team at Syracuse. He retired in 1987 after 40 years as plant manager for General Box Company in Detroit. He was a member of Birmingham Senior Men's Club; Ingleside Bridge Club and Michigan Grouse Unlimited. He enjoyed fishing, small game hunting and was an avid vegetable gardener. He is survived by his wife, Kathleen and three brothers, including Martin F. Hilfinger Jr., Pi '39.

**Richard T. Kent, Xi '48**, lead founder of the Epsilon Omega died March 4, 2002 as he was about to embark on a vacation to Antigua. He was 75. Brother Kent was the former vice president and treasurer of the Bristol-Myers Company. He served in the Navy from July 1944 to July 1946. After the war, he attended Wesleyan College then transferred to Northwestern University where he earned a BS degree in business administration.

He began work at the Bank of the Manhattan Company,

which became part of the Chase Manhattan Bank, until 1954, when he became assistant treasurer of McKesson & Robbins. He then became treasurer of REA Express and worked briefly for Doris Duke as a financial advisor before he joined Bristol-Myers as treasurer in 1969. He became vice president and treasurer in 1973

After his retirement in 1989 he volunteered as a case administrator for the American Arbitration Association, and served as a director of Excelsior Income Shares, Inc. and the Greenwich House in New York City. Brother Kent was also a former member of the Advisory Committee of ABN Bank U.S. and the Subcommittee on Treasury of the Pharmaceutical Manufacturers Association. He was a trustee of the Cold Spring Harbor, Long Island Board of Education.

In 1991, he moved with his wife, Georgianne, to Kent, Conn. where he volunteered at the Sharon Hospital and the Housatonic Valley Association. He served on the Kent Zoning Board of Appeals and the Vestry of St. Andrews Episcopal Church in Kent, and was a member of the Kent School Tennis Association.

After graduation he went to work for Southern New England Telephone Company where he remained until retirement some forty years later. He is survived by his wife, Elizabeth "Tommie" Thompson Lozier.

He was deacon at First Presbyterian Church of Glen Ellyn, chairman of the Glen Ellyn Zoning Commission and was chairman of the Glen Ellyn Fire and Police Committee and a village liquor commissioner. He helped establish the Glen Ellyn village Links Golf Course and helped preserve Stacy's Tavern in Glen Ellyn.

He is survived by his wife, Doris.

**Francis A. O'Brien, Psi '58** died on January 1, 2003. He was a great leader at the Psi chapter and well respected by not only his chapter brothers,

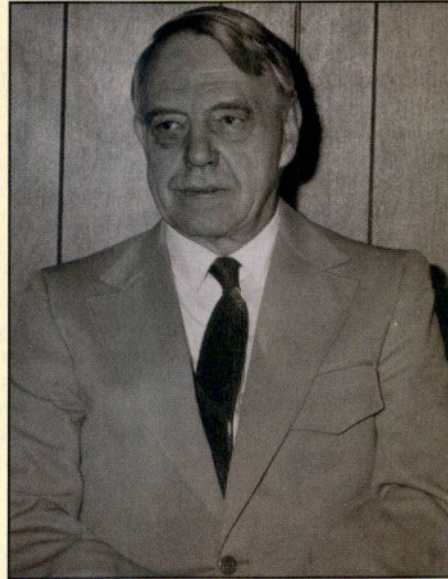

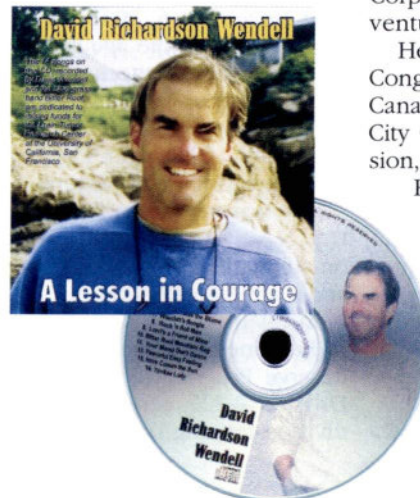

Brother Wendell graduated from Stanford Business School with a master's degree in business in 1979. He began his business career with Saga Inc., rising to chief development officer, then became chief operating officer of Western Atlantic Clubs, a vice president of Montgomery Securities, and strategic adviser to several food companies.



At Dartmouth, Brother Wendell organized the bluegrass band Bitter Root with six friends and it became "the band" for fraternity parties. They also played regular gigs at the Holiday Inn, local bars, and roadhouses. At the members' 20th Dartmouth reunion, the band played to a packed house as the opening act for Livingston Taylor. Wendell contributed a professionally produced CD of his music to help the University of California at San Francisco raise money for its new brain tumor research center. He was an avid athlete, fisherman, hunter, and sailor.

He leaves his wife, Jane.

**Robert E. Witherspoon, Upsilon '35** died on November 16, 2002. He was born and raised in Rochester, New York. After graduating from Rochester and Harvard Business School; Brother Witherspoon worked for various large retailers. Health made him ineligible for military service to his regret, though he left retailing during World War II to work for defense contractor, The Carborundum Corp., as an expeditor of military supplies.

Brother Witherspoon returned to retailing with Scranton's Books and Stationery in Rochester. In 1947, he acquired the Corner Bookstore in Canandaigua which was expanded into the DREW Stationery chain. He later managed a family business, Fairport Storage and Ice Co., eventually becoming its president. He added Happy Ice Corp., Happy Spring Water Corp., and WE Inc. to his ventures.

He was active in the First Congregational Church of Canandaigua, served on the City Council Planning Commission, and was a member of the

Rotary Club and other civic and business organizations. Brother

Witherspoon was well known for his generosity, sense of humor and lively interest in politics. Brother

Witherspoon was also a lifelong supporter of Psi Upsilon. In 1982



Brother Witherspoon served as Memorial Chairman for the Upsilon chapter. He and his brother presented a framed crest to the chapter and he spoke at the dedication ceremony.

He is survived by his wife of almost 62 years, Dorothea; and three daughters and one son, Robert E. Witherspoon Jr, Upsilon '64. He is also survived by his older brother, Charles R. Witherspoon, Upsilon '34. Brother Witherspoon's father and grandfather were also Psi Upsilon brothers.

**Thomas Wyman, Gamma '51**, a former chairman and chief executive of CBS who resigned his membership in the Augusta National Golf Club last fall to protest its refusal to admit women, died on January 8, 2003 due to complications of an abdominal infection.

He graduated from Phillips Academy in Massachusetts, majored in English and was an all-American soccer player at Amherst, and later served as chairman of Amherst's board of trustees.

After graduation, he worked for the First National City Bank in New York. He then served in the Army Corps of Engineers in Korea during the Korean War. He worked for Nestle for 10 years before joining Polaroid in 1965. Later he took charge of Jolly Green Giant, where he changed the focus from canning to fancy frozen vegetables. In the first half of the 1980s he was at the helm of a troubled CBS as president and chief executive before moving on to a seat on the board of General Motors.

In addition to serving on many corporate boards, Brother Wyman was active in many civic and civil rights organizations.

Brother Wyman was one of only four brothers to receive Psi Upsilon's Distinguished Alumnus Award.

His first marriage, to Patricia A. Purdy, ended in divorce. His second wife, the former Elizabeth Minnerly, died in January 2002.

He is survived by his wife, the Rev. Dr. Deborah Whiting Little, whom he married in November 2002. His father was also a Psi U. ♦

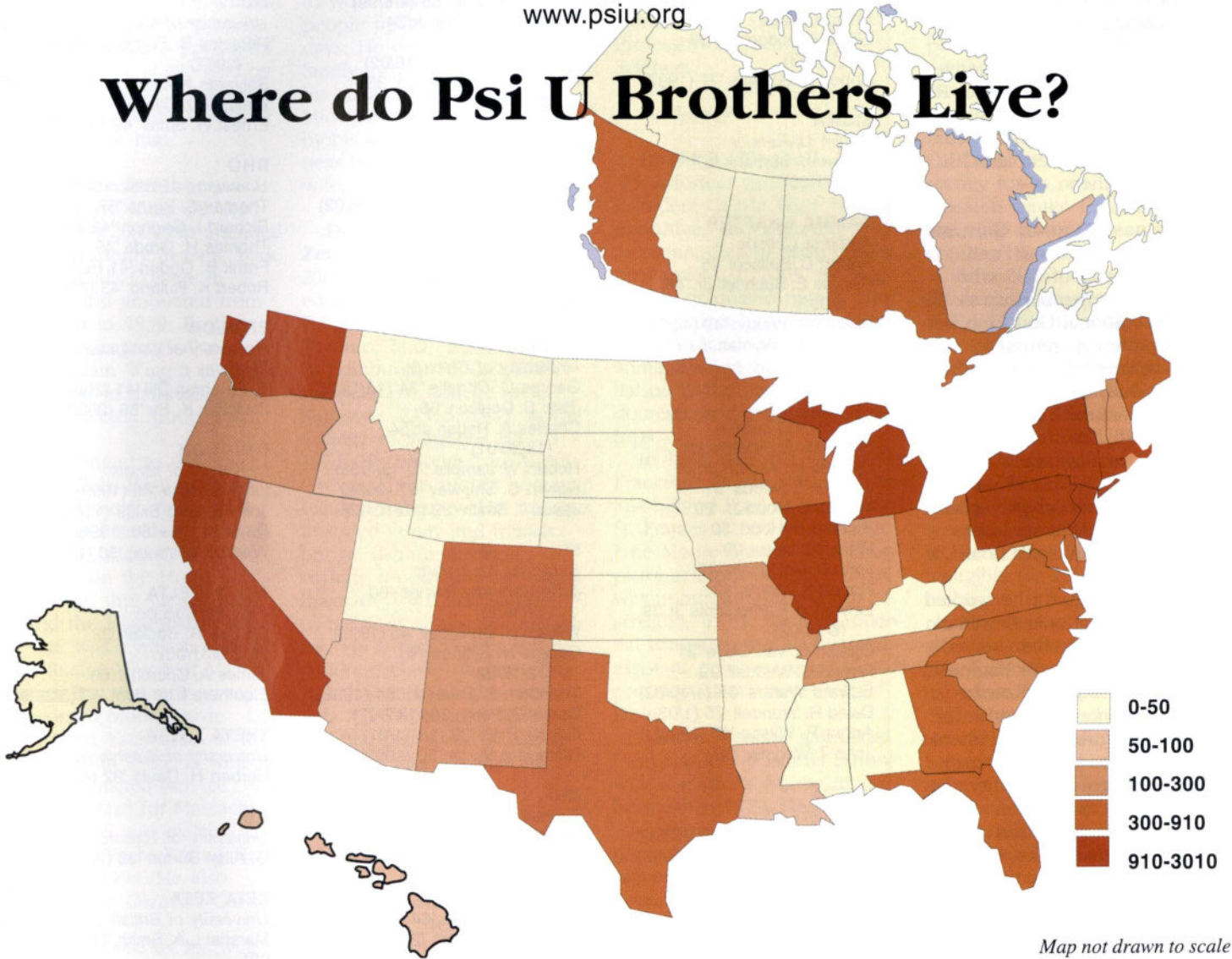
